What is the American Rescue Plan Act (ARPA)?



Covid-19 recovery package signed into law on March 11, 2021, with \$1.9 trillion of programming for emergency stabilization and economic recovery.

- Includes Coronavirus State and Local Fiscal Recovery Fund (SLFRF)
 - \$350 billion for states, municipalities, counties, tribes, territories
 - \$65.1 billion for cities, towns and villages
 - \$65.1 billion for counties
- SLFRF is non-competitive funding every local jurisdiction is entitled to funding.
- Funds must be obligated by Dec. 31, 2024. However, funds do not have to be spent/performed until Dec. 31, 2026.
- First reporting deadline for NEUs is April 30, 2022.
- Local governments can address emergency needs ASAP, and then pause to formulate a long-term plan for remaining funds.

State and Local Fiscal Recovery Funds – Eligible Uses



Treasury identifies 7 broad categories of use and 66 subcategories (see pages 32-32 of <u>Treasury's Compliance and Reporting Guidance</u> for a comprehensive listing of eligible uses – referred to as "expenditure categories").



Support Public Health Response

Fund COVID-19 mitigation efforts, medical expenses, behavioral healthcare, and certain public health and safety staff



Address Negative Economic Impacts

Respond to economic harms to workers, families, small businesses, impacted industries, and the public sector



Replace Public Sector Revenue Loss

Use funds to provide government services to the extent of the reduction in revenue experienced due to the pandemic



Premium Pay for Essential Workers

Offer additional support to those who have and will bear the greatest health risks because of their service in critical infrastructure sectors



Water and Sewer Infrastructure

Make necessary investments to improve access to clean drinking water and invest in wastewater and stormwater infrastructure



Broadband Infrastructure

Make necessary investments to provide unserved or underserved locations with new or expanded broadband access

Eligible Uses: Necessary Water, Wastewater, Stormwater Projects



Coronavirus State and Local Fiscal Recovery Funds – "necessary investments in water, sewer, or broadband infrastructure."

- Projects eligible under the Clean Water State Revolving Fund
 - Construct, improve, and repair wastewater treatment plants; control non-point sources of pollution; create green infrastructure; manage and treat stormwater; water reuse; protect waterbodies from pollution.
- Projects eligible under the Drinking Water State Revolving Fund
 - Build or upgrade facilities to improve water quality; transmission, distribution, and storage systems; consolidation or establishment of drinking water systems
- Cybersecurity
- Climate Change and Resilience
- Lead Service Line Replacement

SRF Project Examples



Clean Water SRF

- City of Wilmington, DE \$15M CWSRF loan to address flooding by replacing their combined sewer system with separate sanitary and stormwater collection systems.
- City of Mariana, FL \$5M CWSRF loan for the installation of two solar facilities and solar arrays at wastewater treatment plant.

Drinking Water SRF

- Town of Selbyville, DE \$3M in DWSRF funding to build a new well, add a transmission line to the treatment plant and build a new treatment plan with aeration capabilities.
- City of Pretty Prairie, KS \$2.4M in DWSRF funding to construct a new reverse osmosis water treatment plant to address nitrate contamination in their source water.

Infrastructure Investment and Jobs Act – \$550 billion in new federal investments for America's infrastructure

Water Infrastructure



Infrastructure Investment and Jobs Act

- \$11.713 billion each for the Clean Water and Drinking Water State Revolving Funds (traditional)
- \$15 billion for lead pipe replacement projects through the Drinking Water State Revolving Loan Fund
- \$10 billion for grants to address emerging contaminants and PFAS drinking water contamination
 - \$1 billion through the Clean Water State Revolving Loan Fund
 - \$4 billion through the Drinking Water State Revolving Loan Fund
 - \$5 billion for underserved communities
- \$75 million for the Army Corps WIFIA program specifically for dams
- \$465 million for the Army Corps Continuing Authorities Program to plan, design and implement smaller, less complex/costly water resources projects
- \$8.3 billion for Western water projects through the Bureau of Reclamation

Build Back Better Act

- \$9 billion for lead pipe replacement grants
- \$225 million for low income water assistance program grants
- \$1.85 billion for sewer overflows and stormwater reuse municipal grants
- \$125 million for alternative water source project grants
- \$150 million for individual household decentralized wastewater treatment system grants (septic systems)
- Excludes water conservation, stormwater management, wastewater management subsidies from taxable income

Climate Change and Resilience



Infrastructure Investment and Jobs Act

- Strengthening Infrastructure Against Extreme Weather Events
 - \$500 million for grants and loans to local communities facing rising water levels, coastal erosion and flooding (STORM Act)
 - \$3.5 billion for the FEMA Flood Mitigation Assistance program
 - \$1 billion for the FEMA Building Resilient Infrastructure and Communities (BRIC) Program
- Reducing Greenhouse Gas Emissions from Transportation
 - \$5 billion for states for a National Electric Vehicle Formula Program for charging infrastructure network buildout
 - \$2.5 billion for competitive grants for EV charging and fueling infrastructure
 - \$5 billion for the replacement of existing school buses with zero emission and clean school buses
- Investing in Clean Energy
 - \$550 million for the Energy Efficiency and Conservation Block Grant
 - \$225 million for grants for implementing updated building energy codes
 - \$3.5 billion for the Weatherization Assistance Program

Build Back Better Act

- Parks Outdoor Recreation Legacy Partnership program
- Buildings Building codes, home energy retrofits, energy efficiency appliance rebates, education and technical assistance
- Reducing Emissions Climate pollution reduction planning + implementation grants, Environmental and Climate Justice Block Grants
- Tax Credits Renewable electricity, renewable fuels, energy efficiency incentives for individuals and businesses, zero emission vehicles
